Hearing scheduled to discuss potential sale of Aaron Hernandez's home

NORTH ATTLEBORO, Mass. - It was the place where Aaron Hernandez was arrested in 2013, and now his North Attleboro home is expected to be sold.

The sale of the million-dollar home comes as Hernandez's former fiancée fights to gain more power over his estate.

Hernandez didn't leave a will, and according to court paperwork his estate is worth zero dollars. His North Attleboro home is listed on Realtor.com at \$1.29 million, and according to the listing it's been actively on the market for more than a year.

The price has been reduced by \$200,000, and the home has a number of unique features including a pool with a waterfall, a movie theater and basement sauna and ice bath.

The home was also significant in the Odin Lloyd murder. Hernandez returned to the home after the killing, and surveillance images showing Hernandez inside were used in court .

Lloyd's body was found in an industrial park not far from the home.

According to the Boston Herald, a lawyer representing Shayanna Jenkins-Hernandez filed an affidavit in court Wednesday, stating he received an offer to buy the home for an undisclosed amount.

The court granted Jenkins-Hernandez the power to sell the home Wednesday, expanding her powers over his estate.

The Hernandez estate is in the spotlight because Lloyd's mother has proceeded with a wrongful death lawsuit.

Jenkins-Hernandez wants to preserve whatever money she gets from the sale of the home for any damages awarded in that case, and anything that may come up in the future as a result of Hernandez's death.

A lawyer representing Ursula Ward has indicated he's been working to bring in offers for the North Attleboro property and when they received an offer, Jenkins-Hernandez and her attorney went to court to make it possible for the home to be sold.

The home is currently empty, so Ward's lawyer had concerns it would lose money if it's not sold.

The pending purchase and sale agreement will be discussed at a hearing in court on Thursday morning.
